AGENCY ADMINISTRATOR'S REPORT TO THE BOARD

- Purchase price of the 2009 Dodge Van was \$17,080.00 incentives changed effective July 1st. Original bid was \$16,500 thru 6/30/2009. Thus, van was an additional \$432 plus applicable fees.
- CESA Networking Update the Response to Intervention Statewide Coordinator has been offered a position. Details for the contract need to be worked out.
- 2000 Series Policies were distributed to Board members for their review with discussion and the first reading of them scheduled for the October 7th Board meeting.
- Sparta Consortium STEM (Systemically Improving Student Academic Achievement in Math and Science). The Math and Science partnership grant is intended to increase the academic achievement of students by enhancing the content knowledge and teaching skills of classroom teachers. The nine school district consortium partners are also utilizing UW-Stout and Western Technical College as partners in higher education.
- Washburn Academy will look at some changes for the summer 2010 professional development offerings.
- Mr. Leavitt provided reflections on the CESA #4 2008 2009 Goals with their outcomes.
- Board Outreach October 22, 2009 from 7 9 pm Attorney Steve Weld, from Weld, Riley, Prenn and Ricci.
- Mr. Leavitt reviewed the results of the Internal Survey conducted by School Perceptions. Culture was a reoccurring theme that came through.
- Three school districts received grant money for the purchase of fresh fruit for their food service programs: Independence (\$10,140); La Crosse Franklin (\$9,186); and La Farge (\$6,125).
- An H1N1 Update will be given to superintendents at the September 8th PAC Meeting from officials from the Jackson and La Crosse County Health Departments.
