- An All-Staff meeting was held on May 20. In addition to regular business items, Gaye Tylka, Early Childhood RtI Statewide Coordinator, was recognized for her 24 years of service with CESA 4.
- Final Washburn preparations are being completed. Both anchor workshops, Responsive Classroom and Professional Learning Community Leadership, have sufficient enrollments to run as proposed. Nearly 200 individuals have registered thus far to participate in one or more Washburn workshops.
- A contract for part-time vision teacher services has been coordinated with CESA 10.

- CESA directors and program assistants participated in discussions during May
 to explore ways to improve service efficiencies. Directors are seeking opportunities to
 collaboratively design initiatives and projects together that are integrated and/or are scheduled
 on the same day(s) when the events involve the same staff. Program assistants are also
 reviewing workloads and assignments in an effort to create cross-training opportunities and
 update and revise job descriptions.
- Budget preparations for the 2016-2017 school year have been a priority activity for all directors.
