- WASB Fall Regional Meeting September 27 at Northside Elementary in La Crosse. Register with the WASB.
- Possible Fall Board Retreat later in October; information on regional teaching training programs and/or teacher retention factors and practices across the state
- Two CESA 4 school districts are presenting referenda questions to voters during the upcoming November election: Melrose-Mindoro and West Salem. Both are proposals to issue debt for facility improvements. The Melrose-Mindoro district is requesting \$24.7M to create a consolidated campus at the high school site. The West Salem ballot will have two questions: 1) \$20M to renovate and furnish the Middle School and the Elementary School and 2) \$5M to replace and/or make improvements to various district athletic facilities.
- The Wisconsin Safe and Healthy Schools (WISH) Center grant provides a number of programs throughout the state. CESA 4 is the fiscal agent for the grant, and the grant director, Tracy Herlitzke, works from an office in our agency. The WISH Center budget for 2015-2016 was over \$1.2M. Funding comes from a combination of state and federal grants to support training events and technical assistance on a variety of topics related to keeping students and schools safe and healthy. Tracy recently provided an annual review and update of the WISH grant activities at a CESA Statewide Network meeting. A copy of her report is included in the handouts for tonight's meeting.
- The Wisconsin Challenge Academy has purchased CESA 4 services to assist with special education programming.
- All-Staff Inservice program was held on August 29. Ten new staff members were introduced.

AUTHORIZATION TO BORROW SHORT TERM FUNDS FOR CASH FLOW PURPOSES
