CAREER AND TECHNICAL EDUCATION PRESENTATION – SHERRI TORKELSON

Quality components of Career and Technical education include: academic and technical skills, leadership and 21st century skills through career and technical student organizations and work-based learning. Effective with the 2015-16 school year, the Wisconsin Technical Education Scholarship (\$2,250 per year) is awarded to one student in each high school who demonstrates high levels of proficiency in technical education subjects and who will continue in the Wisconsin Technical College System.

Youth Apprenticeship is a highly successful talent acquisition strategy in which employers hire high school juniors or seniors for a one or two-year apprenticeship. During the apprenticeship, the student continues toward high school graduation and takes courses related to the profession as a way of enhancing what is being learned on the job. In 2017-18, 105 students were youth apprenticeship enrollees with 84 active employers in the region. Youth Apprenticeship program areas are:

- o Agriculture, Food and Natural Resources
- Hospitality, Lodging and Tourism
- Marketing
- Architecture and Construction
- Health Science
- Science, Technology, Engineering and Math
- Manufacturing
- Arts, A/V Technology and Communications
- o Finance
- Information Technology
- Transportation, Distribution & Logistics

In 2018-18 Western Technical College taught courses at the local high schools by the high school CTE teachers to over 2,300 students. Upon successful completion, students receive credit from both the high school and Western.

The CESA #4 Local Vocational Education Coordinator (LVEC) will provide leadership and technical support to local district personnel in developing and implementing contemporary Career and Technical Education programs, supported by participating Carl D. Perkins Act district allocations. The Perkins Act provides

challenging academic and technical standards across the schools and prepares students for high-skill, highwage or high-demand occupations in current or emerging professions.

The 7 Rivers Alliance is a tri-state leadership council that boosts economic growth by fostering collaboration in Southwest Wisconsin, Southeast Minnesota, and Northeast Iowa. The 7 Rivers Alliance brings together public and private resources to forge entrepreneurial growth and serves as a clearinghouse of vital information to enhance quality of life in the region. The WISE (Workforce Innovation for a Strong Economy) plan was done by the 7 Rivers Alliance to better understand and address the workforce preparation, retention and recruitment challenges faced by businesses in the area.
